It is eMedAsia's policy to respect your privacy regarding any information we may collect while operating our Website. This Privacy Policy applies to eMedAsia Travel PCR platform (hereinafter, "us", "we", or "eMedAsia"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms of Services posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, eMedAsia collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. eMedAsia's purpose in collecting non-personally identifying information is to better understand how eMedAsia's visitors use its website. From time to time, eMedAsia may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

eMedAsia also collects potentially personally-identifying information like Internet Protocol (IP) addresses for Website visitors and for users who place orders on the Website. eMedAsia only discloses visitors and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to eMedAsia's websites choose to interact with eMedAsia in ways that require eMedAsia to gather personally-identifying information. The amount and type of information that eMedAsia gathers depends on the nature of the interaction. For example, we ask visitors who place order on the Website to provide personal information.

Aggregated Statistics

eMedAsia may collect statistics about the behavior of visitors to its website. eMedAsia may display this information publicly or provide it to others. However, eMedAsia does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, eMedAsia uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. eMedAsia uses cookies to help eMedAsia identify and track visitors, their usage of eMedAsia Travel PCR platform, and their website access preferences. eMedAsia visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using eMedAsia's websites, with the drawback that certain features of eMedAsia's websites may not function properly without the aid of cookies.
